

Thank you for considering donating your vehicle to Universal Chastity Education. Our program relies on the backing of individuals of faith. At this time, UCE can only accept vehicles that are in working, drivable condition.

Donating your vehicle will allow you to contribute towards UCE's life saving mission, gives you a tax deduction, and frees you from the hassle of selling a car: advertisements, strangers visiting your home, phone calls, haggling, etc. If you are interested in donating a vehicle please contact UCE Executive Director, Andrew Dernovsek, at contact@uceglobal.org.

1. **What can I donate?** We accept most cars, trucks, RV's, boats, motorcycles, and trailers.
2. **What about a tax deduction?** Charities which are 501(c)3 approved may receive tax deductible donations. This includes in-kind gifts and services. The following are the basic guidelines for donating a vehicle.
 - o Items given to UCE will be acknowledged with an IRS approved receipt.
 - o This receipt will not have an estimated value. This is per IRS rules.
 - o You must assign a value to the gift when you file your taxes for that year. To estimate the value of your vehicle, you can utilize the Kelly Blue Book at www.kbb.com or request a printout from UCE for the particular make and model of car.
 - o If you assign a value higher than \$500 to your vehicle, you must have a receipt from Universal Chastity Education stating that the vehicle was sold for the amount you wish to deduct or a letter from Universal Chastity Education stating that the vehicle is being used for ministry purposes.
3. **Does it need an appraisal?** If the value of the vehicle is above \$5,000, the donor will need to include an appraisal of the vehicle. If the vehicle was sold by Universal Chastity Education, the amount of the sale will be specified in the documentation sent to you from Universal Chastity Education.

- o An appraisal is a very easy process which takes about an hour and costs under \$100. Appraisers are licensed and are generally very friendly and helpful. For appraisers for different types of vehicles see the yellow pages or contact your tax advisor. UCE would be happy to assist you with this.
 - o Keep the appraisal information and all documents provided by Universal Chastity Education for your tax return. Universal Chastity Education will provide you with all of the necessary documentation and make the donation and receipting process as easy as possible.
4. **What documents/arrangements do I need to donate my vehicle?** You will need the title of your vehicle. Any service records you have will help us in the sale of the vehicle. The following is the typical process for donating a vehicle:
 - o The vehicle needs to be drivable. UCE cannot accept 'junk' vehicles at this time.
 - o We offer free pickup at a prearranged time.
 - o In the month following the date the vehicle was received, you will receive a tax deductible receipt and corresponding IRS forms.
 5. **Do you pick up vehicles outside of Colorado?** This will depend on the value of the vehicle. If you are interested in donating a vehicle please contact UCE Executive Director, Andrew Dernovsek, at contact@uceglobal.org.
